**ENTRY FEE** = \$55.00, Murray H&PC members may deduct \$10 from each entry fee. (Includes \$2.50 per PCAWA entry for the PCAWA Eventing Series & \$5 ground fee. **NO PHONE/FAXED OR LATE ENTRIES ACCEPTED.**

**COMPULSORY HELPERS:** Each rider must nominate a helper over the age of 16 yrs. A rider with 2 horses may get 2 helper jobs. Limited self help available only on consultation with the event secretary & must include a \$20 refundable bond. If you put "self" without consulting the secretary your entry may not be accepted. **No self help is available for riders with 2 horses competing.** A no help fee of \$60 is acceptable. **Entries with a helper will be given preference.** The no help fee is not available for Murray Horse & PC members (members are expected to help or provide a helper).

Limited yards available - \$10 each and booking essential. Canteen open Saturday morning onwards with Saturday evening meal of BBQ meal & sweets @ \$15 per person. Booking essential.

**PROVISIONAL TIMETABLE:** Dressage – 10am Saturday, XC Course Open – 2.30pm Saturday, Show Jumping – 8am Sunday (some E grade classes may showjump on Saturday afternoon), XC Briefing – 8am Sunday, Cross Country – 9.00.am Sunday.

**WITHDRAWALS:** A refund will only be given if a doctor or vet certificate is received by the secretary within two weeks after the event.

**AWARDS:** Small prizes for the winner and runner up of each class. Rossets to sixth place and completion ribbons will be presented unless otherwise advised. Riders are asked to be correctly dressed for presentations. SERIES POINTS will be awarded on a sliding scale as: E grade 7 for a win then 6 etc down to 1 for completion, D grade 7.5 for win then 6.5 down to 1.5 for completion, C grade 8 for a win then 7 down to 2 for completion, B grade 8.5 for a win then 7.5 down to 2.5 for completion, A grade 9 for a win then 8 down to 3 for completion. 3 bonus points will be awarded for a successful upgrade (only 1 upgrade). Combinations must compete in all 3 events to be eligible. Those riders that drop down one grade are not eligible for the series.

**PLEASE NOTE:** NO DOGS ARE ALLOWED ON MURRAY HORSE & PC GROUNDS – Those that bring a dog will be asked to leave.
