

**TOWNSHIP OF PEMBERTON**  
**ORDINANCE NO. 19-2009**

**AN ORDINANCE TO AMEND THE ORDINANCES OF  
THE TOWNSHIP OF PEMBERTON, COUNTY OF BURLINGTON,  
STATE OF NEW JERSEY AND SPECIFICALLY CHAPTER 151,  
ENTITLED "SMOKING"**

**BE IT ORDAINED**, by the Township of Pemberton, in the County of Burlington and State of New Jersey, as follows:

**SECTION I.**

The Township Council hereby amends Chapter 151 of the Code of the Township of Pemberton, entitled "Smoking," as follows:

1. Deleting §151-3(B.) in its entirety.
  
2. Adding a new section designated as subparagraph (4) within §151-3(A.) to read: "(4) On any property, including areas outside buildings, owned by the Township of Pemberton excepting public roads and streets."

**SECTION II.**

This Ordinance shall take effect upon final passage and publication according to law.

**SECTION III.**

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

**SECTION IV.**

If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision and the remainder of this Ordinance shall be deemed valid and effective.
